

RELEASE AND WAIVER OF LIABILITY FOR USE OF I-49 Fun Center INDOOR PLAYGROUND FACILITY.

I recognize that the use of I-49 Fun Center LLC recreational facility, including the inflatable units, have inherent risks of injury. For and in consideration of I-49 Fun Center LLC permitting me to use their recreational facility and inflatable's. I, my spouse, assignees, heirs, guardians, and legal representatives hereby voluntarily indemnify, release from liability, agree to defend and hold harmless I-49 Fun Center LLC and its owners, trustees, employees, agents, representatives, and any department, organization or group affiliated there with for any accident, injury, illness, death, loss, theft, damage to person or property, or other consequences suffered by me or my child/children arising or resulting directly or indirectly from my use of the Recreation Facility and inflatable equipment, including but not limited to claims arising from or related to I-49 Fun Center LLC's negligence and/or products liability, including strict products liability. In the event that I am injured, I agree to assume any financial obligation, either through my health insurance, or through some other means, for any medical costs that I or my child/children may incur. I-49 Fun Center LLC assumes no responsibility for any medical expenses, injury, or damage suffered by me or my child/children in connection with my use of the I-49 Fun Center facility or its equipment.

IT IS MY INTENTION BY SIGNING BELOW TO EXPRESSLY ASSUME ALL RISK OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE UPON MYSELF, TO THE EXCLUSION OF I-49 Fun Center LLC, AND TO EXEMPT AND RELIEVE I-49 Fun Center LLC FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH.

By signing this agreement, I waive my right to bring any legal action now or at any time in the future to recover any compensation or obtain any other remedy for any injury to me or any member of my family, or our property or for a death, however caused, arising out of our use of the I-49 Fun Center LLC Recreational Facility. I further agree that I, my spouse, assignees, heirs, guardians, and legal representatives will not make any claim against, sue or attach the property of I-49 Fun Center LLC for any loss or damage resulting from my use of the I-49 Fun Center LLC Facility or equipment. I am aware of the potential dangers incidental to use of inflatable equipment, that this is a release of liability, a waiver of my legal right to collect damages in the event of injury, death or property damage, and a contract between I-49 Fun Center LLC and me, and I sign it of my own free will. I expressly agree that this release is intended to be as broad and inclusive as the State of Missouri will allow and that if any portion is held invalid, I agree that the balance shall, notwithstanding, continue in full legal force and effect. This contract shall remain valid for one full year from the date signed and shall include any and all occurrences be it today or in the future up to and including all visits between now and one year from now.
